This will remain our priority during this national crisis but alongside this we need to pay particular attention to emerging concerns around the COVID19 pandemic and any possible adverse effect that may have on our business communities.

At this stage, incidents of crime and Anti-social behaviour have fallen due to the government guidance on movement, but we can not be complacent.

The Business Crime Team has been created to keep a strategic overview on incidents and ongoing issues that have a direct effect on businesses. A Crime Against Business Strategy has been implemented with the objectives of increasing confidence in the business communities, improving crime prevention and strengthening partnership working and approaches to ongoing concerns. The Business Crime Team have already reached out to hundreds of local businesses and will continue to do so during this extraordinary time.

National Intelligence Picture

Government guidelines around the COVID19 pandemic have had an impact on criminality seeing some offenders change from their normal offending patterns to new or different offences. The main patterns being noticed are:

- Pharmacies being broken into and theft of prescription pain killers as the government restrictions have an impact on 'County Lines' and the supply and distribution of prohibited drugs.
- Warehouses and storage sites being targeted as the buildings remain unstaffed. Premises of national electrical chains are having walls rammed and electric goods stolen.
- Pubs and bars being targeted for cigarettes and cash from machines
- Theft of cigarettes and alcohol from service stations
- Construction sites being targeted for tools and machinery as sites are left vacant.
- Theft from HGVs as the vehicles become more recognisable as motorways are clearer of traffic and less patrols by police traffic vehicles. HGVs are also being targeted at fuel forecourts and are having side curtains slashed. Drivers sometimes being robbed.
- Offenders following home delivery vehicles of companies who are now leaving goods on doorsteps to achieve social distancing. Offenders are lifting goods from doorsteps. Incident in Avon and Somerset of a robbery from an Amazon driver, vehicle and all parcels stolen.
- NHS PPE stolen, uniforms and ID cards so offenders can gain entry to hospitals and storage sites. Uniform and ID also being used for drug distribution by county lines. The belief that dealers will be less likely to be stopped if in uniform.


The Emergency Keyholders List
